At the core of our mission is our belief that only a free, independent, and accountable media can play a critical role in promoting good governance. We believe that it is only by facilitating civic participation and debate can transparency and accountability be expected from the government.

We further believe that it is the concept and principles of Self-regulation that will promote media to be responsible for the publication of news, reports, and articles. This is extremely important today, in a time of "fake news", given the speed and need for credible news on numerous platforms whether traditional or constantly developing dynamic new ones.

Our CEO has given a detailed report of the activities and impact of the Press Complaints Commission during the course of this year (2019). I would only add that it has a very trying time with two events that occurred this year. One was the suicide bombing on Easter Sunday when hundreds of worshippers at Churches and Five Star hotels lost their lives affecting the very soul of the whole country in diverse ways. The other was the Presidential election which was influenced greatly by the national security and safety factor.

In spite of these challenges, PCCSL continued with its work undaunted, with the Dispute Resolution Council meeting, deciding and resolving many issues and complaints received by the PCCSL and brought up before them. The Council members must be applauded for the time given and effort taken to resolve matters.

I must also extend my deep appreciation to my colleagues on the PCCSL Board for their advice especially the Deputy Chairman, to Sukumar Rockwood, our CEO and his able assistants for their positive contribution towards the success of the organization.

# Message from the Chairman of the Dispute Resolution Council (DRC)

The Press Complaints Commission of Sri Lanka (PCCSL) is a totally independent voluntary self regulatory mechanism, which was the outcome of the Colombo Declaration on Press Freedom and Social Responsibility which is now in its 16<sup>th</sup> year (founded on October 15, 2003) and continues to champion the primary objective of self regulation.

It works on the principles of conciliation, mediation and arbitration under he Arbitration Act No. 11 of 1995 and is modeled along the lines of similar commissions in South Africa and Scandinavian countries. The High Court of Colombo is empowered to enforce an arbitration made under the Act.

During this year the Dispute Resolution Council has met on six occasions. We have had valuable participation from the 11 members. The newspaper Editors have extended their full cooperation, and am pleased to record that the voluntary independent self regulatory system has been readily accepted by all registered national newspapers.

The 'Rights of Readers' advertisement has been published as a public service notice and the majority of newspaper editions have continued to give it wide publicity. We hope the other newspapers who have not yet printed the 'Rights of Readers' will soon follow suit.

Throughout the calendar year many important media-related events took place from January to December – around 28 to 30 events took place.

During the year, the PCCSL received 83 complaints of which 56 were relating to the Sinhala language, 12 relating to the English language and five relating to the Tamil language.

I take this opportunity to sincerely thank all 10 members of the Dispute Resolution Council who regularly attended the meetings and helped me in no small way in the conduct of the meetings.

A very special word of thanks to members of the PCCSL Secretariat ably headed by its vibrant CEO Sukumar Rockwood and so very ably assisted by Mr. Kamal Liyanarachchi, Complaints Officer, Sinhala Print for successfully upholding self regulation and its promotion in making the Newspaper Society (publishers) responsible.

# Press Complaints Commission of Sri Lanka Annual Review 2019

#### 01. Introduction

The PCCSL is an independent, voluntary, self-regulatory mechanism set up by the newspaper industry of Sri Lanka, which comprises the Newspaper Society of Sri Lanka, The Editors' Guild of Sri Lanka, the Free Media Movement and the Sri Lanka Working Journalists Association. The PCCSL was inaugurated on October 15, 2003, as a suitable alternative following the removal in 2002 of the Criminal Defamation provisions in the Penal Code. The PCCSL is now in its 16<sup>th</sup> year championing the cause of self-regulation.

It works on the principles of conciliation, mediation and arbitration under the Arbitration Act No. 11 of 1995. It is modelled along the lines of similar Commissions in Scandinavian countries and South Africa. The High Court of Colombo is empowered to enforce an arbitration award made under the Act in the event a newspaper fails to publish the decision of the Dispute Resolution Council of the PCCSL, should a complainant wish to pursue a case where the editor is not abiding by the Council's decision.

The Editors' Code, which is implemented by the PCCSL, provides for conditional third party complaints. Third party complaints are entertained from environmental groups, animal welfare groups, adults on behalf of minors, an immediate family member of an accident victim, an immediate family member of a person in custody and anyone complaining on behalf of another provided the prior written permission of the person personally affected is obtained.

Reporters without Borders has ranked Sri Lanka at number 126 in the World Press Freedom Index of 180 countries in the world for 2019. Sri Lanka ranked 141 in 2017 and 131 in 2018.

The Colombo Declaration on Press Freedom and Social Responsibility, which was the foundation of the Press Complaints Commission of Sri Lanka (PCCSL), celebrated its 20<sup>th</sup> anniversary in September 2018. The Colombo Declaration was an outcome of an international seminar held in Colombo, organized by the Newspaper Society of Sri Lanka, The Editors' Guild of Sri Lanka and the Free Media Movement in association with the Sri Lanka Working Journalists Association, the World Association of Newspapers, the Commonwealth Press Union, the International Press Institute, Article 19 and the Media Institute of Southern Africa.

#### 02. Executive summary

The Press Complaints Commission of Sri Lanka (PCCSL) continued building on the positive growth made in the previous year and successfully held 30 meetings attended by 595 publishers, editors, sub-editors, desk heads, journalists, provincial correspondents and members of civil society, which comprise non journalists. During the meetings, the importance of self-regulation and the Editors' Code of Professional Practice were discussed along with the PCCSL process in resolving complaints.

The voluntary independent self-regulatory system is accepted by all registered National newspapers printed and published in the country. This can be measured in many ways:

- (a) The number of valid complaints received, i.e. complaints received falling within the mandate of the PCCSL. However, complainants remain sluggish in following up on their initial (informal) complaint, while editors are eager to resolve them when informed.
- (b) The number of complaints resolved directly by editors or 'instant complaints' has maintained stability indicating that editors continue to follow the self-regulatory process. The increased number of 'Right of Reply' responses in the form of corrections, clarifications, apologies published by Sri Lankan

newspapers without formally involving the PCCSL indicates that the advocacy work done by the Commission has made readers write direct to editors and have their 'Right of Reply' published without the PCCSL getting involved.

- (c) The PCCSL also observes violations of the Code and these are brought to the notice of the respective editors who respond positively by introducing positive steps in their newspapers which help reach the objective of a professional and responsible media.
- (d) The PCCSL has been informed by several publishing houses that because of the intervention of the PCCSL in resolving complaints and training journalists, as to the application of the Editors' Code to guide them to be more professional and socially responsible when writing stories, they have been able to avoid going to court and facing hefty legal fees.
- (e) The publication of the public notice 'Rights of Readers'. Although, some newspapers do not publish the public notice, they adhere by the PCCSL requirements in resolving complaints.

#### 2.1: Responsibilities of Media Institutions and Personnel

All media institutions/personnel in the print media presently adhere to the Code of Professional Practice of The Editors' Guild of Sri Lanka and enforced by the Press Complaints Commission of Sri Lanka and adopted by the Sri Lanka Press Institute, the Sri Lanka College of Journalism, the Newspaper Society of Sri Lanka, the Free Media Movement, the Sri Lanka Working Journalists Association, the Sri Lanka Tamil Media Alliance, the Sri Lanka Muslim Media Forum, the Federation of Media Employees Trade Union, and the South Asian Free Media Association – Sri Lanka Chapter. All media institutions/personnel co-operate with the Press Complaints Commission of Sri Lanka and adhere to the communications of the Commission's Secretariat and the adjudications of the Commission's Dispute Resolution Council.

#### 2.2: Press Council issues:

On May 17, 2019, the Press Council published an advertisement calling for applications to recruit a 'News Investigator – English,' to inquire and receive complaints against defamation or false news statements as per the Sri Lanka Press Council Act No. 05 of 1973.

The new Council appointed in July 2018, continued into 2019 without change. They are: Advocate Koggala Wellala Bandula, Chairman; Prof. Emeritus Sunanda Mahendra; Ariyananda Dombagahawatte (Senior Journalist – Editor, Irida Lankadeepa); Muditha Kariyakarawana (Senior Journalist – President, Sri Lanka Press Association) and Mr. S. Thillainathan (Senior Journalist – former Editor, Thinakaran). Following Mr. Thillainathan's death in 2019, veteran journalist Thevathasan Senthilvelavar was appointed on September 30. He was former Editor of Thinakaran; Mr. Somaweera Chandrasiri (trade union activist) and on his death in 2019, Mr. M. D. P. Kumara Dharmarathna was appointed. Attorney-at-Law Sudarshana Gunawardana (Director General, Govt. Information) was replaced in 2019 by Mr. Nalaka Kaluhewa and Mr. Niroshan Thambawita, Press Commissioner. The new Board was appointed for three years (2018-2020).

The Sri Lanka Press Council continues to register the first publication of a newspaper under the Sri Lanka Press Council Law No. 5 of 1973 and as amended in 1994 and 2013.

Meanwhile, media organisations at a meeting in the SLPI Board Room, unanimously reiterated their support for the SLPI going to Courts against the Press Council since it is not a properly constituted body. The SLPI in 2019, along with its constituent parties held consultations with its lawyers on a further challenge to the legality of the Press Council. This is in keeping with the commitment to the principles and values articulated in the Colombo Declaration of 2018, which includes reforms to media laws and in so doing calls for repealing the Press Council Law of 1973 in view of the self-regulatory initiatives currently in force, namely the Press Complaints Commission of Sri Lanka.

On Nov. 04, Elections Commission Department, Research and Planning Director Channa P. de Silva forwarded the Press Council Code to Editors of all newspapers. The PCCSL which had also received a copy, shared with him the Editors' Code, which all journalists adhere to, which was accepted through a letter from them thanking the PCCSL.

#### 2.3: Proposed Media Authority Act:

Following the seminar held to mark the 20<sup>th</sup> anniversary of the Colombo Declaration on Media Freedom and Social Responsibility in September 2018, Mr. Dieter Loraine, Managing Director, Albany Associates Limited, UK was tasked with outlining a draft Act including concerns, articulated at the 20<sup>th</sup> anniversary of the Colombo Declaration. Mr. Loraine together with Ms. Lindsay Ross of the Commonwealth Media Trust held informal discussions with representatives of The Editors' Guild of Sri Lanka (TEGOSL), the Newspaper Society of Sri Lanka (NSSL), the Sri Lanka Working Journalists Association (SLWJA), the Free Media Movement (FMM) and the Sri Lanka Press Institute (SLPI) on a proposed draft. The draft made suggestions for a proposed Sri Lanka Media Authority Act which would replace the Sri Lanka Press Council Act. The Sri Lanka Press Institute consulted an Attorney conversant in the field of media law to prepare a draft Act.

However, the sudden change of the Prime Minister in October 2018, the Easter Sunday bombing and the unsettled political atmosphere that followed leading up to the Presidential Election of December 2019 and thereafter, has stalled the process.

#### 2.4: Gender issues

A midst the predominantly male-dominated editors, there were four women editors (Ms. Pushpa Rowel, Editor, *Dinamina* newspaper, Ms. Hana Ibrahim, Editor, *Daily/Weekend Express*, Ms. Dharisha Bastians, Editor, *Sunday Observer* and Ms. Mandana Ismail Abeywickrema, Editor, the *Sunday Morning*) and quite a few women deputy editors, news editors, features editors, sub-editors and supplement editors. Ms. Dharisha Bastians resigned from the *Sunday Observer* in mid-December 2019 and Ms. Pushpa Rowel retired on December 31, 2019 after 43 years of service in the *Dinamina*.

#### 03: Total number of newspapers monitored and their frequency

The total number of dailies and weeklies published by the end of the year in the three language streams was 41 newspapers (see below).

List of newspapers published and their frequency (Daily/Weekly):

#### Sinhala language

Dailies: Lankadeepa, Dinamina, Divaina, Ada and Maubima.

Weeklies: Irida Lankadeepa, Silumina, Irida Divaina, Deshaya, Irida Maubima, Lanka, Ravaya, Anidda and Sathi Aga Auna.

Total: dailies 05 + weeklies - 09 = 14 - 34.14%

#### Tamil language

Dailies: Virakesari, Thinakaran, Thinakkural, Uthayan, Metro News, Navamani, Vidivelli and Tamil Mirror.

Weeklies: Virakesari Weekly, Thinakaran Varamanjari, Thinakural Weekly, Uthayan Weekly, Navamani Weekly, Vidivelli Weekly and Valampuri.

Total: dailies 08 + weeklies - 07 = 15 - 36.58%

#### English language

Dailies: Daily Mirror, Daily FT, Daily News, The Island, Ceylon Today and Daily Express.

Weeklies: The Sunday Times, Sunday Observer, Sunday Island, Ceylon Today (Sunday Edition),

Weekend Express and The Sunday Morning. Total: dailies 06 + weeklies – 06 = 12 – 29.26%

#### 04. Complaints

During the period under review (January to December 2019), the PCCSL received **83** complaints. The following is a breakdown of the complaints as against the different language newspapers.

- \* Sinhala language press: **56** complaints.
- \* Tamil language press: **05** complaints.
- \* English language press: 12 complaints.
- \* Not against the print media: **10** complaints

#### 04.01. Position of complaints received:

#### 04.03. Other complaints:

The PCCSL also received complaints of non-payment of prize-money for crossword puzzles, purportedly misleading advertisements published in newspapers, advertorials (paid Editorial content), articles sent for publication that were not published, as well as complaints against the electronic media. These were forwarded to the concerned authorities. There were also complaints of a personal nature which could not be addressed by the PCCSL.

Most of the complaints were made over the telephone and email. It is mandatory that before the complaint process commences, all complainants have to fill in a Complaint Form and after signing it forward it to the PCCSL along with the incorrect article or copy and a letter stating the inaccuracy.

#### 04.04. Complaints resolved outside of the PCCSL process (direct complaints):

The PCCSL monitors the daily progress made by Editors in resolving complaints without involving the PCCSL (direct complaints) and has observed that a total of 300 complaints have been resolved during the year with the publication of a clarification, correction, apology or Right of Reply. This includes 210 concerning Sinhala newspapers, 00 Tamil and 90 English. (please see attached chart)

#### 04.05. Violations of the Code monitored by the PCCSL:

The PCCSL, during the year, monitored violations of the Code in 19 instances in 12 newspapers; (Daily News (1), Divaina (2), Irida Divaina (2), Virakesari (1), Metro News (1), Daily Thanthi (2), Daily Mirror (2), Lankadeepa (1), Ada (1), Ceylon Today (1), Maubima (4) and Thinakkural (1). (please see attached chart.)

#### 05. Rights of Readers

The 'Rights of Readers' advertisement was published as a public service notice and was sent to all newspapers for publication. The following newspapers carried the public notice on a regular basis while some publish it on and off.

#### They are:

- 1. *Wijeya Newspapers Limited:* Daily Mirror, the Sunday Times, Daily FT, Ada, Deshaya and Tamil Mirror.
- 2. Associated Newspapers Ceylon Limited (Lake House): Sunday Observer, Daily News, Dinamina and Thinakaran.
- 3. Express Newspapers (Ceylon) (Pvt.) Limited: Virakesari daily/weekly, Metro News, Daily Express and Weekly Express.
- 4. Free Lanka Newspapers (Pvt.) Limited: Navamani.
- 5. Asian Media Publications (Pvt.) Limited: Thinakkural daily.
- 6. Ravaya Publishers (Guarantee) Company Limited: Ravaya
- 7. Upali Newspapers (Private) Limited: The Island and Sunday Island.
- 8. Anidda Publishers (Guarantee) Company Limited: Anidda

Meanwhile, the Ceylon Today (Daily Edition), Ceylon Today (Sunday Edition), Maubima (Daily Edition) and Maubima (Sunday Edition), Divaina, Irida Divaina and Silumina continue to comply with the PCCSL process, although they do not publish the 'Right of Readers' public notice.

#### **06. Dispute Resolution Council**

The Dispute Resolution Council (DRC) met on six occasions (January, March, May, July, September and November). The Chairman of the 11-member Dispute Resolution Council is former Secretary General of Parliament and Attorney Nihal Seneviratne. The other members are: Dr. Devanesan Nesiah, Mrs. Gnana Moonesinghe, Mr. Lucille Wijewardene, Mr. Javid Yusuf and Mr. Dion Schoorman, who are non-journalist members of the Council totalling six. Mr. Siri Ranasinghe, Mr. Pramod de Silva, Mrs. Vijita Fernando, Mr. Daya Lankapura and Mr. P. Balasingham, are the journalist members on the Council totalling five. Mrs. Vijita Fernando stepped down due to poor health early in the year. Ms. Malini Govinnage was nominated to replace her but also resigned due to poor health at the end of the year she was replaced by Mrs. Rajitha Weerakoon.

#### 07. Membership of PCCSL

Membership of the PCCSL stands at 41 members as of December 31, 2019. Nine vacancies arose with members ceasing to be working journalists.

#### 08. Publicity, awareness and promotional programmes

#### 08.01: Publicity of the PCCSL

#### 08.01(i): Publicity of the PCCSL in the print media

- January 24 to February 03, The PCCSL forwarded a Press Release to newspaper editors concerning complaints recorded in 2018. It was published in 12 newspapers.
- March 05, the PCCSL was invited by 'Sharda TV,' a private Buddhist Channel, based in Kaduwela for an interview that lasted one-hour. It was about PCCSL and how it works. PCCSL's Sinhala Complaints Officer Kamal Liyanaarachchi did the interview.
- May 19, the Sunday Morning newspaper featured an interview of the PCCSL CEO concerning racial discrimination reporting.
- June 09, The *Sunday Observer* newspaper had quotes from the CEO on the Editors' Code, PCCSL process and self-regulation in an article 'Media: A circus running lives?'
- July: The ANCL (Lake House) Group Sinhala daily newspaper published an interview of Sinhala Print, Complaint Officer Kamal Liyanaarachchi concerning the PCCSL and the Editors' Code.
- August 02, The Daily FT newspaper published a ¾ page article on the UN-FAO/PCCSL Seminar titled: 'Balance in food intake essential to prevent malnutrition.' This event was organised by the PCCSL.
- Sept. 06 to 14, a Press Release of the Annual General Meeting was published in 12 newspapers.
- Oct. 16, caption and photograph appears in Daily Mirror of an event the PCCSL was involved in along with the Sri Lanka Press Association at the SLPI. Mr. Kamal Liyanaarachchi along with Mr. Lakshman Gunasekere and Mr. Bennette Rupasinghe were the resource persons.
- November, Elections Commissioner acknowledges the PCCSL Editors' Code with a letter of appreciation and says it will be used along with the Elections Guidelines with reference to reporting in the print and electronic media before, during and after elections.

#### 08.01(ii): Publicity of the PCCSL in the digital media

- January 17, Mr. Dharmasiri Lankapeli, President, Federation of Media Employees Trade Union (FMETU) complaint No: PCCSL/03/12/2018 against Irida Divaina was resolved. Clarification published on Facebook page with thanks to PCCSL.
- Over the last two weeks in January a debate took place with PCCSL participation on social media concerning media practice and ethical reporting of print and electronic media.
- Some citizens discussed the Editors' Code and self-regulation on and off on Facebook.
- Two Members of Parliament, MP Jayampathi Wickramaratne (UNF) said in Parliament and Dayasiri Jayasekara (UPFA) at a press conference mentioned the importance of the PCCSL and Self-Regulation. It was published in Dinamina on Jan. 25, 2019.

#### 08.02: PCCSL and RTI

- The PCCSL continued to assist the SLPI to promote the Right to Information (RTI) in the Provinces by conducting awareness programmes. These programmes were assisted by Mr. Kamal Liyanarachchi, Complaints Officer, Sinhala Print of the PCCSL.
- Mr. Kamal Liyanaarachchi left for New Delhi, India on Sunday, November 24 to attend a Right To Information event.

#### 08.03. Web Page

 The web page – <u>www.pccsl.lk</u> – was updated. A new web page was launched since the earlier one was not compatible with the new server. It has most of the features of the previous web page. *08.04. Programmes with publishers, editors, journalists and provincial correspondents*The PCCSL conducted a total of 17 meetings for 252 people comprising publishers, Editors, Desk Heads, sub editors and journalists.(Please see awareness chart).

#### 08.05. Awareness programmes with civil society

The PCCSL also made positive headway by meeting 343 members representing various sections of civil society at 13 meetings. The role of the PCCSL, Rules and Procedures of the PCCSL and the Editors' Code were explained. These programmes were well attended by government officials, officials from local government institutions, academics, doctors and heads of institutions. They were eager to know more about the PCCSL and how it works. (Please see awareness chart).

#### 09: Closure/change of hands of newspapers and new publications:

**January 21, 2019:** 'Thinathanthi' - the largest selling Tamil-language newspaper in India selling 1.8 million copies a day signed an agreement with the publishers of Virakesari – Express Newspapers (Ceylon) (Pvt.) Ltd – the largest selling Tamil-language newspaper in Sri Lanka to publish an insert of the *Thinathani* in their Monday and Saturday versions. The Agreement was signed by Mr. Hari Selvanathan, Chairman, Express Newspapers and Mr. S. Balasubramaniam Adityan, Group Chairman Thanthi Group in the presence of Mr. Kumar Nadesan, MD, Express Newspapers.

June 09, 2019: The Irida Lakbima, Sinhala weekly ceased publication.

**August 01**, **2019**: The *Sathi Aga Aruna*, a Sinhala language daily published by Liberty Publishers (Private) Limited was launched on August 01, 2019. *The Sunday Morning*, an English language weekly followed thereafter published by the same group.

August 01, 2019: The Journalist Movement for Media Ethics and Social Justice (JMMESJ) Online News Website was launched. An inaugural event for journalists was held at the National Christian Council of Sri Lanka (NCCSL) Auditorium where Mr. Kamal Liyanaarachchi and Mrs. Kshama Ranawana spoke on Ethics, the PCCSL, highlighted self-regulation and the importance of the Editors' Code. PCCSL CEO was the Moderator.

**November 12, 2019:** Jaffna's regional newspaper – *Eelanadu* – re-launched. It was first launched in 1959 by late Mr. K. C. Thangaraja and re-launched after a 30-year break. Its office was burnt in June 1981 when the Jaffna Library was burnt but work recommenced after a few weeks. The LTTE attacked their office in 1987 when the Indo-Lanka Accord was signed. Former Eelanadu senior journalist S. Mahalingasivam (Mali) and S. S. Kuhanathan, Chairman Dish Asia Network (DAN) Television of ASK Media were present at the launch.

In Jaffna, the Yarl Thinakkural, Uthayan and Valampuri continue to be published.

In Kandy and Batticaloa, they have their regional newspapers.

#### 10. Chronology of important media-related events:

Several important media-related events took place;

- January 26, 2019: 'Media and Law' Conference at Water's Edge organised by: National Secretariat for Media Reforms (NSMR), in partnership with Sri Lanka Media Law Forum (SLMLF), Colombo Law Society (CLS) and International Media Support (IMS).
- **January 29, 2019:** Eight media organisations organised a signature campaign and candle light vigil with Free Media Movement organisers at Lipton Square in memory of fallen journalists and impunity against journalists.
- **January 30, 2019:** Launch of Centre for Investigative Reporting (CIR) at Lighthouse, Kadirgamar Institute, Colombo.

- January 31, 2019: Broadcasters meeting at Taj Samudra.
- February 22, 2019: State Minister of Defence Mr. Ruwan Wijewardene has been appointed non-Cabinet Minister for Media. He oversees the following: Information Department, ANCL (Lake House) SLRC, ITN and SLBC. Cabinet Minister Mangala Samaraweera continues as Minister of Media.
- March 02, 2019: Education Ministry taking steps to rectify issues connected with teaching of the revised Mass Communication subject for GCE 'AL students. There is no teacher guidance book. Arrangements are being made by the Education Publications Department to issue such a book before April 21. (Source: Daily News).
- March 06, 2019: Finance and Mass Media Minister Mangala Samaraweera appoints committee to supervise the smooth functioning of Lake House, SLRC, ITN and SLBC. The committee comprises: Prof. Jayadeva Uyangoda, Mr. Nalake Gunawardene, Mr. Wijenanda Jayaweera, Dr. Pradeep N. Weerasinghe, Mrs. Anoma Rajakaruna, Mrs. Kaushalya Fernando and Dr. Sudharshana Gunewardene. (Source: Daily News).
- March 09, 2019: The Sri Lanka Development Journalism Forum (SDJF) met at awarding ceremony of Young Peace Journalists who took part in MediaCorp Fellowship Programme at Hotel Galadari. MediaCorp Fellowship is a part of Media Empowerment for a Democratic Sri Lanka (MEND) implemented by the International Research and Exchange Board (IREX) with support from USAID.
- March 12, 2019: Media Ministry Secretary Mr. Sunil Samaraweera assumes duties. (Source: Ceylon Today).
- March 19, 2019: Launch of Social Media Declaration (Colombo 2019), Code of Conduct for Responsible Social Media Use organised by Centre for Policy Alternatives (CPA). SLWJA and SLMMF are signatories.
- *March 20, 2019:* Sri Lanka Muslim Media Forum organised a discussion on 'Empowering and Sharing Experiences' with Mr. Igbal Athas.
- May 03, 2019: World Press Freedom Day was marked with a seminar organised by the Free Media Movement.
- June 05, 2019: Cabinet approval granted for revision of the Penal Code and Criminal Procedure Code enabling swift and stringent legal action to be taken against those who engage in distribution of false news and hate speech. Anyone found guilty, could face a fine of up to Rs. 1 million or a five-year prison sentence or both. The FMM has written to the Minister of Justice June 19, 2019.
- **June 17, 2019:** The Supreme Court issues strict guidelines for law enforcement authorities while hearing a case involving a minor girl being held by a woman police constable unlawfully.
- July 10, 2019: Parliament Oversight Committee (Sectoral Oversight Committee on Women and Gender) to formulate 'Code of Conduct' on breaking news which is harmful to female victims and their immediate family members. The Committee will also evaluate all media and classify the advertisements, news, dramas, shows and movie according to the level of damage and violations.
- July 10, 2019: It is an offence for an individual or an institution to maintain a television broadcasting station/satellite or cable based broadcasting station within Sri Lanka void of a valid media licence issued by the relevant subject Minister, as per section 28 of Sri Lanka Rupervahini Cooperation Act No. 06 of 1982. August 15, 2019 is the deadline to obtain this licence from the Ministry of Mass Media. (Source: The Island).
- July 26, 2019: Maiden exhibition by the Sri Lanka Photojournalists Association
- August 09, 2019: Speaker Karu Jayasuriya announces that COPE sittings will be opened to the media. The FMM welcomes the action of Parliament as a further step towards free media.
- August 16, 2019: The English language version of the Social Media Declaration, Sri Lanka (2018) Code of Conduct for Responsible Social Media Use, undertaken by the CPA was shared with the PCCSL. The CPA requested the PCCSL's response. Mr. Kamal Liyanaarachchi, Complaints Officer Sinhala Print was invited to be a member of the panel.

- August 22, 2019: The Ministry of Provincial Education, Sabaragamuwa Province has
  instructed all Principals in Schools not to permit journalists to enter their Schools to gather
  news. They have to get permission from the Zonal Director of Education. (Source: Thinakaran).
- August 28, 2019: A number of print and electronic journalists at a forum organised by the Right to Life Human Rights Organisation pointed out the rise in the irresponsible use of social media.
- August 30, 2019: Report on harassment of journalists handed over to Media Ministry Secretary Sunil Samaraweera by chairman of the committee, Mrs. Tilaka Jayasundara that probed the victimisation during the tenure of the Mahinda Rajapaksa regime.
- **September 09, 2019:** President issues Extraordinary Gazette Notice taking over the Sri Lanka Rupavahini Corporation. It now comes under the President and the Defence Ministry. The Editors' Guild of Sri Lanka, the Free Media Movement and the Sri Lanka Working Journalists Association have criticised the President's action.
- **September 11, 2019:** The Editors' Guild of Sri Lanka at their meeting requested the PCCSL to furnish them monthly the violations of the Editors' Code chart and the Direct Complaints handled by editors chart. The PCCSL CEO agreed to forward this soon after each Board Meeting of the PCCSL which is held every first Wednesday of the month.
- **September 15, 2019:** Presidential Elections Law (Act No. 15 of 1981) becomes effective from today says Elections Commissioner.
- **November 02, 2019:** 'International Day to End Impunity for Crimes Against Journalists.' An article 'A new level of audacity for impunity and journalist murders' sent by Mr. Andrew Heslop, Director Press Freedom WAN-IFRA was published in Daily FT (Nov. 02). Daily Mirror (Nov. 02) also featured an article on the 'Third Asian Investigative Journalism Conference,' in Seoul.
- November 04, 2019: Repeat of Ethics covering Election Reporting issued by Elections Commission for print and digital media.
- November 04, 2019: Sri Lanka Working Journalists Association (SLWJA) is in the process of preparing a 'Rights and Responsibilities Charter' for working journalists in Sri Lanka. Already the following media organisations have shared their views: Free Media Movement, Federation of Media Employers Trade Union, Young Journalists Association, Sri Lanka Tamil Media Forum and Sri Lanka Muslim Media Forum. Closing date of suggestions/comments Nov. 12.
- November 06, 2019: Media Minister Mangala Samaraweera tells press conference that the list
  of journalists harassed by the previous regime collected through an advertisement and
  forwarded to Cabinet, has been approved and compensation will be paid to them in the near
  future. The Sunday Morning adds: Journalists who were harassed and persecuted during 2005
  to 2015 period will be compensated. Accordingly compensation from Rs. 200,000 to Rs. 1.5
  million will be paid to 78 journalists. However, several Tamil journalists refused to accept the
  compensation claiming that the victimised journalists need justice to 40 of their colleagues who
  were assassinated and murdered during this period.
- November 07, 2019: The media should be guaranteed the space to conduct their profession in a free and responsible manner during the Presidential Election states the Free Media Movement (FMM) in a media release. It adds: 'The Provincial Journalist Collective recently held a press briefing and revealed information regarding the harassment and obstructions faced by regional journalists across Sri Lanka from various political party organizers and supporters during the reporting of the presidential election. According to the information received by the Free Media Movement, various political parties have refused to give access to individual journalists covering their presidential election campaign meetings after inquiring the name of the media institution they represent.
- Mr. Kamal Liyanaarachchi left for New Delhi, India on Sunday, November 24 on a Right to Information event. He will return in ten days.

- The PCCSL Board of Directors continued to meet once a month. The Annual General Meeting (AGM) took place on September 04, 2019.
- Board members: Mr. Kumar Nadesan (Chairman, nominee of SLPI), Mr. Sinha Ratnatunga (Deputy Chairman, nominee of The Editors' Guild of Sri Lanka), Mr. Nimal Welgama (nominee of the Newspaper Society of Sri Lanka), Mr. Ananda Jayasekera (nominee of the Free Media Movement), Mr. Manik de Silva (nominee of the SLPI), Mr. Duminda Sampath (nominee of the Sri Lanka Working Journalists Association), Mr. Siri Ranasinghe, Mr. M. N. Ameen and Mr. Mohanlal Piyadasa were re-elected by the general membership of the PCCSL.



## Code of Professional Practice (Code of Ethics) of The Editors' Guild of Sri Lanka adopted by the Press Complaints Commission of Sri Lanka

#### 01. PREAMBLE

This code of practice, which is binding on newspaper publishing companies, Editors and their journalists and contributors both in print format and online, aims to ensure that the Sri Lankan press is free and responsible and sensitive to the needs and expectations of its readers, while maintaining the highest standards of journalism.

Those standards require newspapers to strive for accuracy and professional integrity, and to uphold the best traditions of investigative journalism in the public interest, unfettered by distorting commercialism or by improper pressure or by narrow self-interest, which conspires against press freedom. Newspapers and journalists, while free to hold and express their own strong opinions, should give due consideration to the views of others and endeavour to reflect social responsibility.

This code both protects the rights of the individual and upholds the public's right to know. It should be honoured not only to the letter but in the spirit – neither interpreted so narrowly as to compromise its commitment to respect the rights of the individual nor so broadly as to prevent publication in the public interest.

Editors should co-operate swiftly with the Press Complaints Commission of Sri Lanka (PCCSL) in the resolution of complaints. Any publication judged to have breached the Code must print the adjudication in full and with due prominence, including a headline reference to the PCCSL.

#### 02. ACCURATE REPORTING

- 2.1: The media must take all reasonable care not to publish inaccurate, misleading or distorting news, photographs and other images. Any significant digital manipulation of images should be labelled.
- 2.2: Every reasonable attempt should be made by editors and individual journalists to verify the accuracy of reports prior to publication. Where such verification is not practicable, that fact shall be stated in the report.
- 2.3: Editors and their staff, including external contributors, shall not publish material in such a way as to endorse any matter which they know or have reason to believe to be false or inaccurate.
- 2.4: Plagiarism must be avoided. Legitimate use of other people's work should be duly attributed.
- 2.5: The press must distinguish clearly between comment, conjecture and fact.

#### 03. CORRECTIONS and APOLOGIES

3.1: Where it is recognized by the editor that a report was incorrect in a material respect, it should be corrected promptly and with due prominence and with an apology where appropriate, except where the correction or apology is against the wishes of the aggrieved party.

#### **04. OPPORTUNITY TO REPLY**

4.1: A fair and reasonable opportunity to reply should be given to individuals or organizations in respect of factually incorrect statements endangering their reputation, dignity, honour, feelings, privacy and office. The mutually agreed reply should be confined to the complainant's version of the facts and no longer than necessary to correct the alleged inaccuracy.

4.2: Newspapers or journalists who respond to a complainant's reply other than to apologize or regret the error, must then be prepared to offer the aggrieved party a fresh opportunity to reply.

#### **05. CONFIDENTIAL SOURCES**

5.1: Every journalist has a moral obligation to protect confidential sources of information, until that source authorizes otherwise.

#### 06. GENERAL REPORTING and WRITING

- 6.1: In dealing with social issues of a particularly shocking or emotionally painful nature such as atrocity, violence, drug abuse, brutality, sadism, sexual salacity and obscenity the press should take special care to present facts, opinions, photographs and graphics with due sensitivity and discretion, subject to its duty to publish in the public interest.
- 6.2: In reporting accounts of crime or criminal case, publications shall not, unless it is both legally permitted and in the public interest –
- i. Name victims of sex crimes.
- ii. Knowingly name any young person accused of a criminal offence who is below the age of 16 and who has no previous convictions.
- iii. Identify without consent relatives of a person accused or convicted of a crime.
- 6.3: A journalist shall not knowingly or wilfully promote communal or religious discord or violence.
- 6.4: i. The press must avoid prejudicial or pejorative reference to a person's race, colour, religion, sex or to any physical or mental illness or disability.
- ii. It must avoid publishing details of a person's race, caste, religion, sexual orientation, physical or mental illness or disability unless these are directly relevant to the story.
- 6.5: When reporting suicide, care should be taken not to give excessive detail of the method used.

#### 07. PRIVACY

- 7.1: The press shall exercise particular care to respect the private and family lives of individuals, their home, health and correspondence, including digital communications. Intrusions on this right to privacy without consent could be justified only by some over- riding public interest.
- 7.2: The use of long-lens or other cameras to photograph people without consent on private or public property where there is a reasonable expectation or privacy is unacceptable, unless in the public interest.
- 7.3: Particular care should be taken to ensure that in cases involving grief or shock, inquiries and approaches are handled with sensitivity and discretion.
- 7.4: Young people should be free to complete their school years without unnecessary intrusion. Publication of material concerning a child's private life would be acceptable only if there was some exceptional public interest other than the fame, notoriety or position of his or her family or guardian.
- 7.5: The restrictions on intruding into privacy are particularly relevant to inquiries about individuals in hospitals or similar institutions, unless it serves the public interest.

#### 08. HARASSMENT and SUBTERFUGE

8.1: Journalists, including photo-journalists, must not seek to obtain information or pictures through intimidation or harassment or by misrepresentation or subterfuge. The use of long-lens cameras or listening devices, or interception of private or mobile telephone calls, e-mails or messages is

unacceptable unless this can be justified in the public interest and the material could not have been obtained by other means.

#### 09. INTEGRITY

- 9.1: All journalists should act with integrity and honour in the performance of their work.
- 9.2: Conflicts of interest should be avoided. Journalists should inform their editor or responsible superior of any possible conflict, such as close personal connection with any story in which they are significantly engaged; or acceptance or offers of gifts that might compromise their integrity. If such conflict is unavoidable, it should normally be disclosed to the reader.
- 9.3: i. Even where the law does not prohibit it, journalists must not use for their own profit financial information they receive in advance of its general publication, nor should they pass such information for the profit of others.
- ii. They must not write about shares or securities in whose performance they know that they or their close families have a significant financial interest, without disclosing the interest to the publisher, editor or financial editor.
- 9.4: Articles written for payment or other benefit from a commercial or other non- editorial source, such as in advertorials or promotions, should be clearly labelled as such. Payment should not be sought or accepted as a reward for including favourable or excluding hostile editorial material.

#### INTERPRETATION

- 1: Public Interest' means:
- i. Protecting democracy, good governance, freedom of expression, human rights and keeping the people informed of the actions of their elected representatives and government.
- ii. This also includes, but is not confined to:
- Detecting or exposing crime or the threat of crime;
- Disclosing a person or organisation's failure or likely failure to comply with any legal obligation to which they are subject;
- Disclosing a miscarriage of justice;
- Raising or contributing to an important matter of public debate, including serious cases of impropriety, unethical conduct or incompetence concerning the public;
- Disclosing concealment, or likely concealment, of any of the above:
- Protecting public health and security and social, cultural and educational standards;
- Protecting the public from being misled by some statement or action of an individual or organisation.
  - 2: In any case where the public interest is cited, the Press Complaints Commission will require the Editor and/or journalist to demonstrate that the breach was proportionate to the public interest served.

#### **ONLINE PUBLICATIONS**

The provisions of this Code will also apply to the Online publications of the print media, where:

- The editor of the newspaper, magazine, or freestanding web publication is ultimately responsible for it and could reasonably have been expected both to exercise editorial control over it and apply the terms of the Code before publication.
- The material used has not been pre-edited to conform to the on-line or off-line standards of another media regulatory body.

#### **REVIEW**

The Editor's Guild of Sri Lanka shall review the provisions of this Code from time to time, in consultation with a Code Committee comprising of members, and non-members appointed by the Guild.

## RULES AND PROCEDURES OF THE PRESS COMPLAINTS COMMISSION OF SRI LANKA

#### A. MAKING A COMPLAINT

- 1. Any person who reasonably believes that he or she or another person/s have been adversely affected by any published item including a news story, article, photograph and/or graphic ("Published Item"), that appeared in a newspaper or a magazine or a Journal or an Online edition thereof published in Sri Lanka may make a complaint to the Press Complaints Commission of Sri Lanka ("PCCSL"). Such complaint shall satisfy the following requirements:
  - (a) it shall be in the prescribed complaint form, which may be downloaded from the PCCSL website, at http://www.pccsl.lk/make\_complainant;
  - (b) it shall be a concise statement in writing, describing the issue and shall be duly signed by the complainant;
  - (c) it shall be communicated to the PCCSL in person, by registered post, facsimile, e-mail or any other electronic means;
  - (d) any Published Item/s in an online edition (website) can either be downloaded and a print out obtained and/or forwarded to the PCCSL if such Published Item is available on the online edition and or traced from any archive of the online edition or any link to that online edition.
  - (e) the Published Item alleged to have affected the complainant adversely shall be annexed to the complaint; provided however, that where the complaint is made via e-mail or any other electronic means, the complainant shall attach the Published Item to the complaint.
  - (f) Where the complainant is unable to find a copy of the Published Item, the PCCSL Secretariat shall make every endeavour to assist the complainant in finding such Published Item.
- **2.** (a) The complainant may request the PCCSL to:
  - (i) settle a dispute by conciliation
  - (ii) settle a dispute by mediation; or
  - (iii) refer the matter for adjudication by arbitration

Provided however that in the event that pursuant to action taken by the Dispute Resolution Council of the Commission (hereinafter referred to as the "Council") as set out under (7) below, the editor of the relevant newspaper, journal, magazine or online edition thereof agrees to publish a correction and/or apology and/or a right of reply, which in the Council's view addresses and rectifies the issue complained about, the parties shall not proceed to conciliation, mediation and/or arbitration.

- (b) Where the complainant requests the PCCSL to refer the matter for adjudication by arbitration, the complaint must, in addition to the requirements set out under (1) above, satisfy the following requirements:
  - (i) the material facts and circumstances of the dispute shall be set out;
  - (ii) a statement of evidence shall be provided; and
  - (iii) the relief sought by the complainant shall be specified.
    - **3.** A complaint made against any Published Item after one year from its publication shall not be entertained by the PCCSL.

#### B. THE ROLE OF THE COUNCIL

- **4.** The Council shall accept a duly received complaint only if it deems, at its complete discretion that the Published Item referred to has breached the Code of Professional Practice of the Editors Guild of Sri Lanka for the time being, as adopted by the Sri Lanka Press Institute ("SLPI") and the PCCSL.
- 5. Where the members of the Council are of the opinion that the Published Item has not breached the Code of Professional Practice of the Editors Guild of Sri Lanka, it shall reject the complaint and provide reasons therefor in written form, to the complainant within two (2) weeks of receiving the complaint. In the event that notice of refusal has not been provided to the complainant it shall be deemed that the complaint has been accepted by the Council with effect from the date on which the same was received by the Council.
- 6. Once the complaint is accepted, the Council shall within one (1) working day thereof, communicate the same to the editor of the newspaper, journal, magazine or online edition there of which contained the Published Item which allegedly adversely affected the complainant, along with a copy of the complaint. The Council shall, along with such communication call on the said editor to act on the complaint and/or reply to the Council on the complaint within a period of five (5) working days of receiving the communication.
- 7. In the event that the editor of the newspaper or magazine to whom the communication is made as aforesaid, does not respond to the same by the due date, the Council shall forthwith directly refer the complaint to the publisher for action on the matter and/or a reply to the Council; provided however that where the editor or the publisher (as the case may be), or a person acting for and on behalf of such editor or publisher requests for time to reply, such further time may be granted by the Council at its discretion.

Provided further, that if a correction and/or a right of reply is published in the newspaper, journal, magazine or online edition, it would be deemed to be a reply.

**8.** The Council shall make all endeavours to facilitate the parties to enter into a settlement within the shortest period of time, but not later than two (2) weeks from the date of accepting the complaint.

#### C. CONCILIATION

- **9.** Where a complainant has, along with the complaint, made a request to the PCCSL that the matter be settled by conciliation, the Council shall refer such request to the Chief Executive Officer of the Council (CEO) for conciliation. A settlement agreed upon by the parties may include a correction and/or apology and/or a right of reply.
- **10.** Where there are existing circumstances or those that may arise, which are likely to give rise to reasonable doubt on the impartiality and independence of the CEO to whom the matter is referred for conciliation, the CEO shall disclose such circumstances to the Council in writing and the Council shall refer the complaint to a member of the Council for conciliation.
- 11. In the event that the Council is of the opinion that the matter is not likely to be resolved through conciliation, the Council may propose, for the consideration of the parties, other means of resolving the dispute.

#### D. MEDIATION

- **12.** Where a complainant has, along with the complaint, made a request to the PCCSL that the matter be settled by mediation, the Council shall refer such request to the CEO or three members of the Council for mediation.
- **13.** (a) Where there are existing circumstances or those that may arise, which are likely to give rise to reasonable doubt on the impartiality and independence of the CEO or a member of the Council to whom the matter is referred for mediation, the CEO or the member of the Council (as relevant) shall disclose such circumstances to the Council in writing and shall not act as mediator in such matter;
- (b) In the event that such a written disclosure of interest in the matter is provided by the CEO or any member of the Council (as relevant) appointed to mediate the matter, as stipulated in (a) above, the Council shall appoint another member of the Council in place of the member withdrawing.

- **14.** In the event that the CEO or the Council is of the opinion that the matter is not likely to be resolved through mediation, the Council may propose, for the consideration of the parties, other means of resolving the dispute.
- **15.** The Council shall determine the procedure for mediation so as to facilitate an expeditious and economical resolution of the dispute by mediation. In general:
  - (a) each party shall be given a fair hearing and an opportunity to present its case in conformity with the principles of natural justice;
  - (b) a dispute shall be settled within two (2) weeks of the date when the dispute was referred to the CEO or three-members of the Council (as relevant), however this period may be extended at the request of the parties;
- **16.** Mediation proceedings shall terminate:
  - (a) upon the parties reaching a settlement agreement;
  - (b) upon a declaration issued by the Council on the recommendation of the CEO or the three members of the Council (as relevant) appointed to mediate the matter, stating that it is unlikely that the proceedings would lead to the resolution of the dispute; or
  - (c) upon a written request by any one of the parties requesting for the termination of mediation proceedings.

In the event that mediation proceedings terminate on the grounds provided under (b) and (c) above, the Council shall refer the matter for arbitration by the Council as provided for under Part E below; provided however that a member who was involved in mediation proceedings shall not be appointed to the panel of arbitrators. Provided however that a complainant may withdraw the complaint should he or she not be willing to proceed to arbitration.

#### E. ARBITRATION

17. The request made to the PCCSL by a complainant to arbitrate a dispute between himself and a member of the PCCSL, arising from any publication in the press of Sri Lanka, or the consent of the complainant to any referral for arbitration made by the Council in terms of clause 11 or clause 16 above, together with the deemed consent of the member of the PCCSL in terms of article 12 of the articles of association of the PCCSL, shall be deemed to be an arbitration agreement" within the meaning of the Arbitration Act No. 11 of 1995 between the said member of the public and the particular member of the PCCSL to refer such dispute for resolution by Arbitration.

- 18. Where a complainant has, along with the complaint, made a request to the PCCSL that the matter be settled by arbitration, or where the Council has referred the matter for arbitration further to clause 11 or clause 16 above, the Council shall appoint a three (3) member panel of the Council as arbitrator and refer the dispute to such panel for arbitration.
- **19.** Where the parties to the dispute object to the appointment of one or more of the member/s constituting the panel the Council shall appoint another member or members of the Council in place thereof.
- **20.** (a) Where the three member panel of the Council sits as the arbitrator:
  - (i) the quorum for any adjudication thereby shall be two (2) members;
  - (ii) the Council shall always maintain a non-press related members majority; and
  - (iii) the majority opinion shall prevail, provided that in the event a matter is taken up by two (2) arbitrators forming the quorum, a decision shall require unanimity.
  - (b) The three (3) member panel of the Council may, at its discretion, refer any matter to a fuller panel with the consent of the parties. The quorum in such event shall be two (2) members less than the composition of the relevant panel.
    - 21. Where there are existing circumstances or those that may arise, which are likely to give rise to reasonable doubt on the impartiality and independence of any member of the Council to whom the matter is referred to for arbitration, such member of the Council shall disclose such circumstances to the Council in writing and shall not act as arbitrator in such matter.

In the event such a written disclosure of interest in the matter is provided by the member of the Council appointed to arbitrate the matter, as stipulated in (a) above, the Council shall appoint another member of the Council in his/her place.

- **22.** The Council shall determine the procedure for arbitration so as to facilitate expeditious and economical resolution of the dispute. In general:
  - (a) each party shall be given a fair hearing and an opportunity to present its case in conformity with the principles of natural justice;
  - (b) at the request of the arbitrator, the parties shall state the evidence on which they wish to rely on, specifying what they wish to prove thereby;
  - (c) the Council shall require the parties to the dispute to be comprehensive in any or all statements submitted and in case the complainant fails to comply with such requirement, the arbitrator may at his discretion dismiss the case; provided however that in the event the relevant editor and/or publisher fails to comply with the said requirement, such failure shall not prevent the continuation of proceedings;

- (d) in the event that a party fails to appear at a hearing or otherwise comply with an order and does not show valid cause for such failure, such failure shall not prevent the arbitrator from proceeding with the case or rendering an award;
- **23.** The arbitrator shall grant an arbitral award in accordance with the following:
- (a) the powers of the arbitrator to award relief in arbitral proceedings shall be limited to making an order to the editor and/or publisher to publish a right of reply and/or correction and/or apology in the media in which the relevant publication took place, unless the power to award any other relief is expressly conferred on the arbitrator in writing by the parties. Provided however that the arbitrator may specify a date and/or a page number and/or placement on a particular page of the said publication including online editors for the execution of the arbitral award;
- (b) an arbitral award shall be made after having conscientiously considered and evaluated all aspects of the proceedings and after the arbitrator determines what has been proved in the case;
- (c) an arbitral award shall be made not later than one (1) month from the date on which the matter was referred for arbitration;
- (d) a separate issue or part of the matter in dispute between the parties may at the request of a party be decided by a separate award; provided however that where the other party objects to the same, a separate award may be rendered by the arbitrator if it is deemed that there are exceptional reasons therefor;
- (e) where a party has partially admitted a claim, the arbitrator may give a separate award on the part that has been admitted;
- (f) in the event a settlement is made, the Council may at the request of the parties, confirm such settlement in the award.
- (g) a correction, change or interpretation of the award may be given effect to in the following circumstances, provided that the relevant parties to the arbitration have been presented an opportunity to express their views:
  - (i) any obvious miscalculation or clerical error in an award shall be corrected by the arbitrator;
  - (ii) the arbitrator may decide a question which should have been decided in the award but which was not decided therein, in the event that a party to the arbitration requests for the same within thirty (30) days of the award;
  - (iii) the arbitrator may provide an interpretation of the award in writing provided that the same is requested for by a party to the arbitration within thirty (30) days of the award;
  - 24. An arbitral award by the Council of the PCCSL is equivalent to an award by an arbitral tribunal under the Arbitration Act No. 11 of 1995. As such, an

arbitral award by the Council may be enforced in terms of the Arbitration Act No. 11 of 1995, by applying to the High Court within one (1) year following the expiry of fourteen days from the date of the award.

- **25.** The fee and costs of arbitration shall be decided by the Council and the Council shall prescribe how and by whom such fees and costs shall be paid.
- **26.** Once arbitration proceedings close, the arbitrator shall submit to the PCCSL, a copy of the award as well as a record of all proceedings.

#### F. MAINTENANCE OF RECORDS

27. The CEO shall maintain records of all complaints including telephonic and verbal communications relating thereto and decisions of conciliation, mediation and arbitration proceedings, and shall make available to the PCCSL an annual report of the complaints made, adjudicated and pending, which will be made available to the public thereafter by way of a publication by the PCCSL.

#### G. NOTICES

- **28.** Any document, addressed to the PCCSL and sent by courier or by registered post shall be deemed to be given, made or received by the PCCSL on the day it was so delivered or on the day following that on which it is posted as the case may be.
- 29. The spokesperson for all complaints received and decisions made by the Council will be the CEO, provided however that the CEO may consult the chairman of the Council where it is prudent to do so. In any event no details will be provided to the press and/or electronic media and/or public regarding ongoing inquiries, and no interpretation of any arbitral awards made by the Council will be made by the CEO unless after consultation with the chairman of the Council and/or arbitrator.
- **30.** All press releases and verbal statements on matters relating to the PCCSL, made to the public and/or other media, by the CEO will require the prior sanction of the chairman of the PCCSL provided that if they relate to any matter involving a complaint, the provisions of clause 29 shall apply.

#### H. REVISION OF RULES

**31.** These procedures will be reviewed annually or as and when required and if necessary revised and submitted by the CEO to the Council for approval and to the Board of Directors of PCCSL for ratification and implementation.
